

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to horsemanwrestling.com and Horseman Wrestling and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Horseman Wrestling include horsemanwrestling.com and Horseman Wrestling. The Horseman Wrestling website is a Ecommerce, business, portfolio, educational site. By using the Horseman Wrestling website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Horseman Wrestling may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
